Scholarships

Air Force Association provides degree-focused scholarships and grants for U.S. Air Force personnel and their spouses to pursue associate/bachelor undergraduate or graduate/postgraduate degrees. Preference will be given to wounded personnel or a surviving spouse, dependent child or grandchild of personnel killed or wounded while on active duty as a result of their service to our nation. Applicants must be pursuing a degree at an accredited college, university, or trade school, and be a Veteran who has served honorably in the United States Armed Forces, a surviving spouse, dependent child or grandchild of a U.S. Veteran (DD 214 or proof of military service required). Deceased or wounded Navy or Marine personnel must have been performing official military duties in a combat situation or military training exercise (DD form 1300 or DD 214 required). General Eligibility: Applicants must be under 24 years old. Applicants must have a parent eligible for MOAA membership or be children of active duty, Reserve, National Guard, or retired enlisted military personnel. If the applicant served in a uniformed service before completing college, his or her maximum age for eligibility will be increased by the number of years he or she so served, up to five years. Spouses may apply year-round (no deadlines) and must re-apply every year.

National Guard Educational Foundation (NGEF) – NGEF, DRS Technologies Create College Scholarship For Children of Fallen National Guardsmen: The National Guard Educational Foundation (NGEF) created a college scholarship fund for the children of more than 650 National Guardsmen killed in the war on terrorism. DRS Technologies, Inc. of Parsippany, N.J., will provide up to \$6,250 per year to selected students attending a four-year institution or a two-year program at a community college or technical school. National Military Family Association awards scholarships for military spouses of all uniformed service members. AFAS General Henry H. Arnold Education Grant Program - \$4,000 The General Henry H. Arnold Education Grant Program is offered to eligible Air Force dependents. Grants are awarded to selected sons and daughters of Active Duty, Title 10 AGR/Reserve, Title 32 AGR performing full-time active duty, Retired, Retired Reserve and deceased Air Force members; spouses of Active Duty members and Title 10 AGR/Reservists; and surviving spouses of deceased

personnel for their full-time undergraduate studies. For more information or to apply, please visit the scholarship provider's website.

Designated Scholar Program: We consider all loan recipients for this program. Students chosen receive a \$6,500 interest-free loan and a \$500 grant named by the donor. Students must correspond with the donor or their designee each fall.

Federal Supplemental Educational Opportunity Grant (FSEOG) – 2.ed.gov/programs – Provides need-based grants to low-income undergraduate students to promote access to postsecondary education. Students can receive these grants at any one of approximately 4,000 participating postsecondary institutions. Priority is given to those students with "exceptional need" (those with the lowest expected Family contributions, [EFCs], at the institution) and those who are also Federal Pell Grant (see # 84.063, also under topical heading "Federal Student Aid") recipients. **Teacher Education Assistance for College and Higher Education Grant (TEACH Grant)** – teach-ats.ed.gov/ – TEACH Grant Initial and Subsequent Counseling and A TEACH Grant Agreement to Serve (ATS) so that you may receive one or more TEACH Grants to pay for your education.

General John Paul Ratay Educational Fund Grants: These grants are limited to children whose military parent retired and subsequently died. Students qualifying for a loan who meet the criteria of a Ratay grant are automatically considered. Students who believe they are eligible for these grants and who do not receive a request for supporting documentation should email <u>edassist@moaa.org</u>. Funding for this grant is limited, so we might not award these annually.

Senior Grants: We notify current loan recipients entering their final year in college of these grants in January of their junior year. Students who believe they are eligible for these grants and who do not receive an emailed link to the application should email <u>edassist@moaa.org</u> for additional information. Recipients of Senior Grants become ineligible for further Educational Assistance programs. The number of grants awarded varies from year to year.

The Academic Competitiveness Grant (ACG) -

The grant covers occupations which must: • Involve skills that are customarily learned in a practical way through a structured, systematic program of on-the-job supervised learning; • Be clearly identified and commonly recognized throughout an industry; • Involve the progressive attainment of manual, mechanical, or technical skills and knowledge; and • Require related instruction to supplement on-the-job learning. Industry-Recognized Apprenticeship Programs are high-quality apprenticeship programs recognized as such by a Standards Recognition Entity (SRE) under DOL's standards. These programs provide individuals with opportunities to obtain workplace-relevant knowledge and progressively advancing skills. IRAPs include a paid-work component and an educational component and result in an industry-recognized credential. An IRAP is developed or delivered by entities such as trade and industry groups, corporations, nonprofit organizations, educational institutions, unions, and joint labor-management organizations.
